- 4. The quotation should be accompanied by:
 - (a) original copy of bank receipt of State Bank of Sikkim for non-refundable deposit of Tender Fee of Rs. 5,000.00 (Rupees five thousand only) under revenue head 0070.800.04.Other Receipts(Finance)
 - (b) certified copy of appointment as authorized distributor or agent or stockiest of the concerned manufacturing company and
 - (c) details of warranty scheme for each item of supply.
- 5. The sealed quotations will be opened at 11:00 am on Tuesday the 7th January 2025 in the head office of Commercial Taxes Division at Deorali, Gangtok.
- 6. The Lowest Bidder should be able to supply all the hardware within fifteen days of issue of supply order. Otherwise, the supply order would stand cancelled automatically and quotation of second lowest bidder shall be considered for awarding the supply.
- 7. The quantity of items mentioned in the Table above may increase or decrease at the time of issue of supply order.
- 8. The Commissioner of Commercial Taxes reserves the right to reject any quotation wholly or partly without assigning any reason thereof. His decision in relation to the quotation and supply shall be final.
